1. I declare that I am an authorized representative of the Business and the Business adheres to the following LiveSmart BC: Small Business Program eligibility requirements:
 - a. The Business is privately owned and operated;
 - b. The Business is registered to operate in the Province of BC;
 - c. The Business has 50 employees or less;
 - d. The Business has a Small Commercial gas account with FortisBC;
 - e. The energy efficiency measures that the Business is applying for FortisBC and LiveSmart incentives will be implemented in the Business' B.C. location;
 - f. The Business has not participated in, nor is eligible for the LiveSmart BC: Efficiency Incentive Program (energy efficiency incentives for residential buildings)
 - g. The Business is not a residential building (e.g. condo or apartment building).
2. I have applied to or intend to apply to FortisBC Energy Inc or FortisBC Vancouver Island Energy Inc ("FortisBC") for rebates offered under FortisBC's Efficient Boiler program, Light Commercial Energy Star[®] Boiler program and/or Efficient Commercial Water Heater program on behalf of the above named Business. Further, I have read and the Business complies with the terms and conditions of the applicable FortisBC program.
3. I am applying for additional rebates for high efficiency boiler and/or water heater installations from the LiveSmart BC: Small Business Program payable through FortisBC under one or more of the eligible FortisBC programs.

I acknowledge and agree that:

- a. The Province of British Columbia, through the LiveSmart BC: Small Business Program is contributing incentives to eligible participants in FortisBC's Efficient Boiler, Light Commercial Energy Star[®] Boiler, and Efficient Commercial Water Heater programs.
- b. In order to estimate the energy savings from the Business, I will, if requested, provide the Business Energy Advisor ("BEA") named below access to the Business' utility bills or on-line utility account.

- c. For reporting purposes, FortisBC may provide the Province with information such as the Business name, items installed and estimated natural gas and greenhouse gas emissions savings associated with the upgrades completed.
- d. All information collected and retained by the Province of BC will be managed in accordance with the BC *Freedom of Information and Protection of Privacy Act*.
- e. Subject to d (above), this information and the information on this declaration form will be used solely by FortisBC and the LiveSmart BC: Small Business Program for the purpose of collaborating on the delivery of rebates, determining eligibility, determining energy savings and CO₂ emission reductions, and evaluating the effectiveness of the relevant program and I am giving consent to MEM to provide a copy of this document to FortisBC for the purposes of this application. Your business' information will not be shared or published. Only aggregate data on program-wide energy performance will be shared.
- f. By applying for the LiveSmart BC: Small Business Program incentive, the Business assumes full responsibility for the eligible equipment installed under the Program, and I, an authorized signatory on behalf of the Business, release the Province of BC its employees, officers and agents, FortisBC, and their employees, officers and agents from claims of any nature, including claims for injury or damages, made by any person involved in the activities of the LiveSmart BC: Small Business Program.
- g. The Business is required to keep all receipts for upgrades completed under the FortisBC Light Commercial Boiler Program and the Efficient Commercial Water Heater Program as per the FortisBC program policies.
- h. The Province of BC, LiveSmart BC, British Columbia Hydro and Power Authority and FortisBC do not endorse the services of any contractor, nor any specific products, and accept no liability in the selection of materials, products and contractors or performance or workmanship.
- i. I understand that the Business may be contacted at a later date by the Province for Program Evaluation purposes and the Business will, on request, provide receipts documenting the work completed that was eligible for incentives under the LiveSmart BC Small Business Program and/or copies of my electrical and/or gas utility bills;
